

GMI Edge Trading Platform API Terms & Conditions ("Terms & Conditions")

By accessing or using GMI Edge Trading Platform API ("API"), you agree to be bound by these Terms & Conditions. If you are using the API on behalf of an organization, you represent and warrant that you have the authority to bind that organization to these Terms & Conditions. If you do not agree to these Terms & Conditions, do not access or use the API.

1. Platform Exclusivity and License Grant

API is a service provided by **GMI** Global Market Index Limited ("GMI"), a registered company organized under the laws of St. Lucia, and its licensors and is available only for use with the GMI Edge Trading Platform.

Access to and use of the API is strictly limited to accounts and trading activities conducted on the GMI Edge Trading Platform.

No support is provided for third-party platforms or any other systems outside of GMI Edge Trading Platform.

Subject to your full compliance with these Terms & Conditions, GMI hereby grants you a limited, non-exclusive, non-transferable, non-sublicensable, revocable license to access and use the API solely in connection with your authorized use of GMI Edge Trading Platform.

GMI and its licensors retain all right, title, and interest in and to the API, API documentation, trademarks, trade names, and all related materials. Except as expressly granted herein, no ownership or license is conveyed.

2. No Guarantee of Profit or Performance

GMI, as the service provider, offers the API solely as a technical tool for automation on the GMI Edge Trading Platform.

GMI does not guarantee the profitability, performance, accuracy, or suitability of any trading bot, strategy, or algorithm built or run via the API.

You are fully responsible for the design, operation, and monitoring of any trading bots or automated systems connected to your GMI Edge trading account.

3. Limitation of Liability

GMI, its affiliates, and service providers accept no liability for any direct, indirect, incidental, or consequential losses arising from the use or attempted use of the API on the GMI Edge Trading Platform.

This includes, but is not limited to, losses resulting from market movements, technical failures, delays, outages, disconnections, software bugs, or incomplete or delayed order execution.

You acknowledge and accept that all trading activities—manual or automated—are inherently risky, and you bear sole responsibility for all outcomes.

You acknowledge that use of the API is at your own risk and that you are solely responsible for evaluating its suitability for your intended use.

4. User Responsibility

You are responsible for keeping your GMI Edge trading account credentials and API access information secure and confidential.



You accept all responsibility for activities conducted using your credentials, including any orders submitted, modified, or cancelled via the API.

If you suspect any compromise of your account or API keys, you must notify GMI Customer Service immediately.

GMI reserves the right to revoke or disable your API access at any time if GMI suspects unauthorized API access.

5. Exclusive Use with GMI Edge Trading Platform

The GMI Edge API is strictly for use with the GMI Edge Trading Platform. Integration, data access, or trading activities on other trading platforms or external services are not supported and are strictly prohibited.

6. Bot Hosting & Operation

Trading bots developed using the API must run on your own hardware, such as a personal computer, server, or VPS (Virtual Private Server).

Bots will not execute orders or perform any functions unless the hosting machine is operational and connected to the internet.

GMI is not responsible for failures or missed trades due to the hosting environment or internet connectivity issues.

7. No Liability for Third-Party or External Code

GMI does not review or endorse any trading bots, scripts, or other automated tools created by users of the API or by third parties. The Company makes no representations or warranties and is not responsible for the content, quality, security, or operation of any trading bot or script. You use the code at your own risk.

GMI shall not be liable for any damages or losses arising from malicious, harmful, or defective code, including but not limited to issues caused by backdoors, malware, or other unauthorized functions introduced by third-party developers or providers.

8. Proper Use and System Integrity

You agree to use the API only as expressly permitted in these Terms & Conditions and in accordance with applicable laws and regulations, GMI policies and guidelines. Without limiting the foregoing, you shall not:

- Use the API in any manner that violates any applicable laws, regulations, or thirdparty rights;
- Copy, modify, reverse engineer, decompile, disassemble, or otherwise attempt to derive the source code of the API;
- Use the API to create a product or service that competes with GMI offerings;
- Use the API in a way that could harm, disrupt, or otherwise interfere with the performance, security, or integrity of GMI services or systems;
- Share, sublicense, or otherwise provide access to the API or your credentials to any third party without our prior written consent;
- Use the API for any prohibited activity.

Prohibited activities include, but are not limited to:

• Sending excessive or abusive numbers of orders (including pending orders) that disrupt, overload, or spam the system;



- Attempting to manipulate market pricing, execute unauthorized trades, or gain unfair advantage through technical or systematic means;
- Using the API for denial-of-service (DoS) attacks or any activity threatening the stability, security, or integrity of GMI, GMI Edge Trading Platform, or associated systems.

GMI reserves the right to monitor API usage and to **limit, suspend, or terminate** access (with or without notice) in the event of abuse, misuse, or any activity deemed harmful, suspicious, or in violation of these Terms & Conditions.

9. No Warranties

The API and all related services are provided on an "as is" and "as available" basis without warranties of any kind, either express or implied. To the fullest extent permitted by applicable law, GMI disclaims all warranties, express or implied, including but not limited to warranties of merchantability, fitness for a particular purpose, non-infringement, and accuracy of data.

GMI does not warrant that the API will operate uninterrupted, be error-free, secure, or free from viruses or other harmful components. GMI makes no guarantees regarding the availability, reliability, or performance of the API, or that the API will meet your requirements or function as intended in conjunction with your systems, applications, or trading strategies.

GMI reserves the right to modify, suspend, or discontinue API access at any time for maintenance, upgrades, or to protect platform integrity and security.

10. Indemnification

You agree to defend, indemnify, and hold harmless GMI, its affiliates, officers, directors, employees, consultants and agents from and against any and all claims, damages, obligations, losses, liabilities, costs, or debt, and expenses (including but not limited to attorney's fees) arising from your use of the API; any violation of these Terms & Conditions or applicable law; any infringement or misappropriation of third-party rights, including intellectual property or data privacy rights; any trading or financial activities conducted using API/bots and other tools connected to API.

11. Amendments to the Terms & Conditions

GMI may update or revise these Terms & Conditions at any time. Updates will be communicated through official GMI channels. Continued use of the API constitutes acceptance of any changes.

12. Termination

GMI reserves the right to terminate, suspend, or restrict your API access at its sole discretion, without prior notice, for any violation of these Terms & Conditions, suspected abuse, security concerns, or any behavior considered detrimental to GMI, the GMI Edge Trading Platform, or its users.

13. Governing Law



These Terms & Conditions are governed by the laws of St. Lucia. Any disputes arising under or in connection with these Terms will be subject to the exclusive jurisdiction of the courts of Saint Lucia. Nothing in this clause shall prevent GMI from initiating legal proceedings in any other jurisdiction, including (but not limited to) the jurisdiction where the API user is located.

Risk Disclosure

Automated trading on the GMI Edge Trading Platform involves significant risk. GMI does not guarantee performance or results, and past outcomes are not indicative of future returns. Only use trading bots and automation tools if you fully understand the risks involved.
